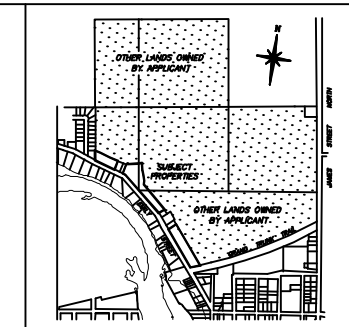

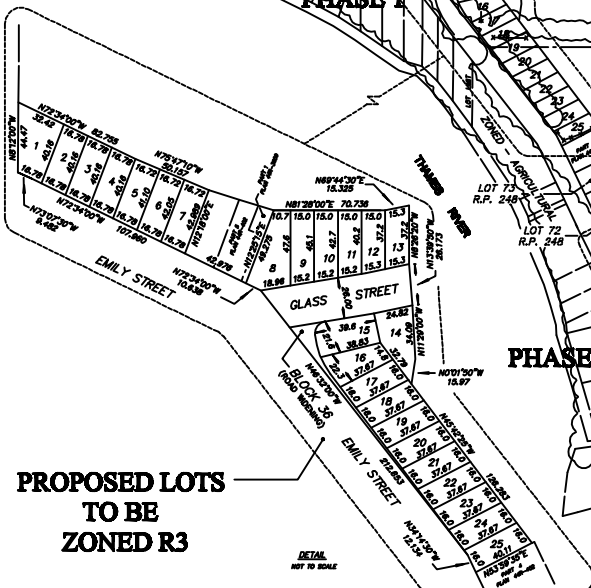

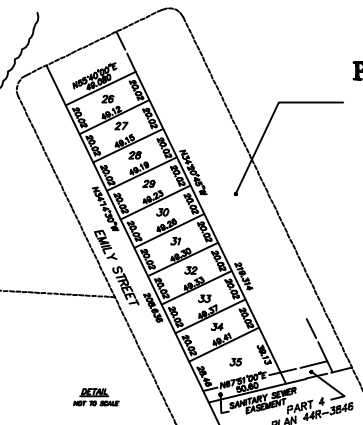
KEY PLAN
